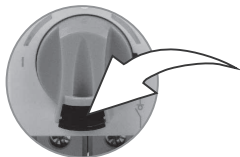
Purpose

Modular network-aggregate installation switch PSR-440 implements switching program I-0-II, so it is possible, for example, to connect them to the output of one of the two input lines, or completely disconnect the circuits. The contacts of the switch act as a disconnecter, so it is possible to switch up to the rated load current.



The switch has the possibility to lock the drive.

The location of the lock is shown in the figure below:

to lock the drive

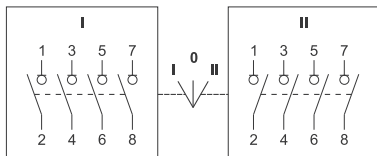
Characteristics

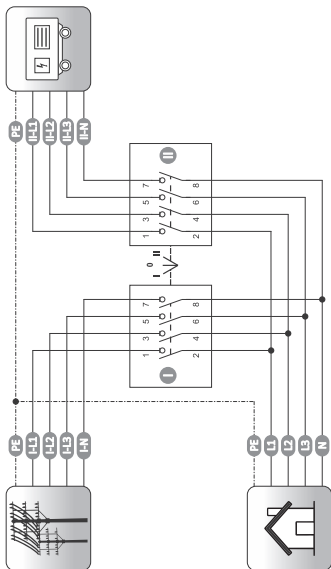
- » The main contacts (L1, L2, L3, N) are switched on/off simultaneously;
- » Mechanical protection to prevent simultaneous switching on of both power sources or immediate switching from one line to the other without passing through the 0 position;
- » Possibility of 1-phase and 3-phase operation.



For 1-phase installations, connect the supply phase to the L1, L2, L3 terminals of the switch.
