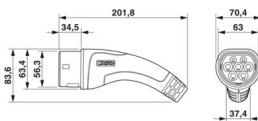

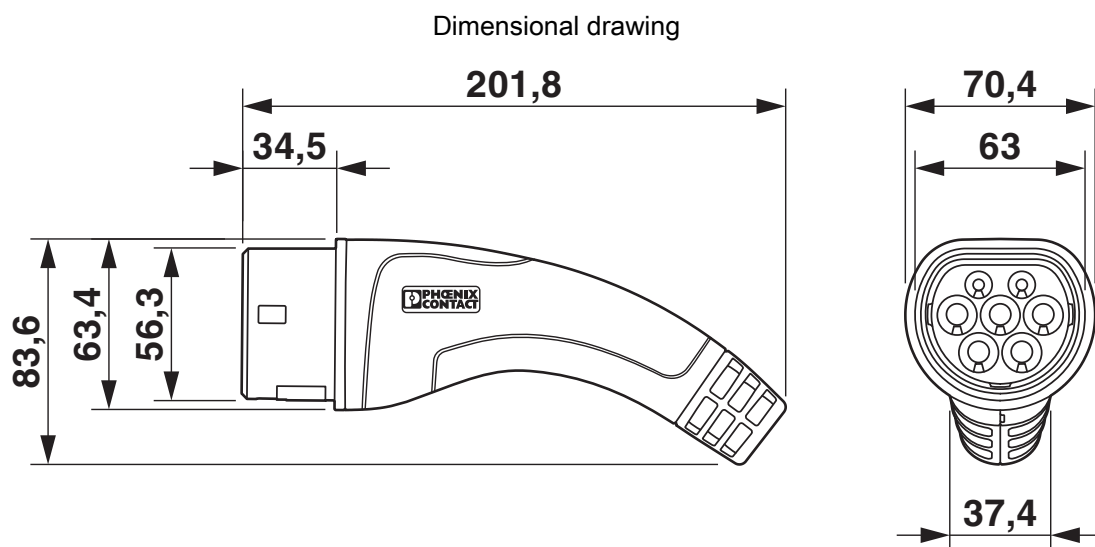

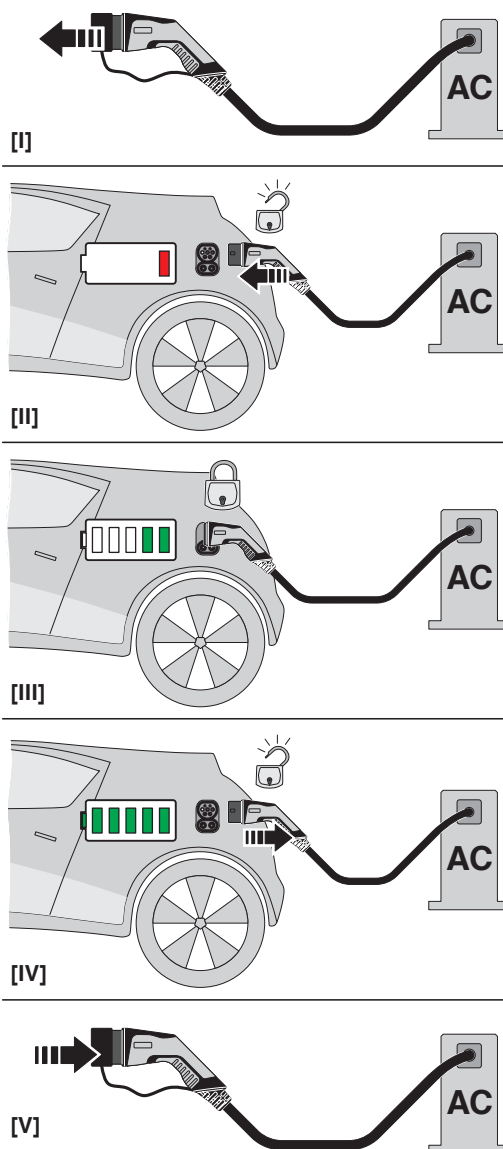

Schematic diagram

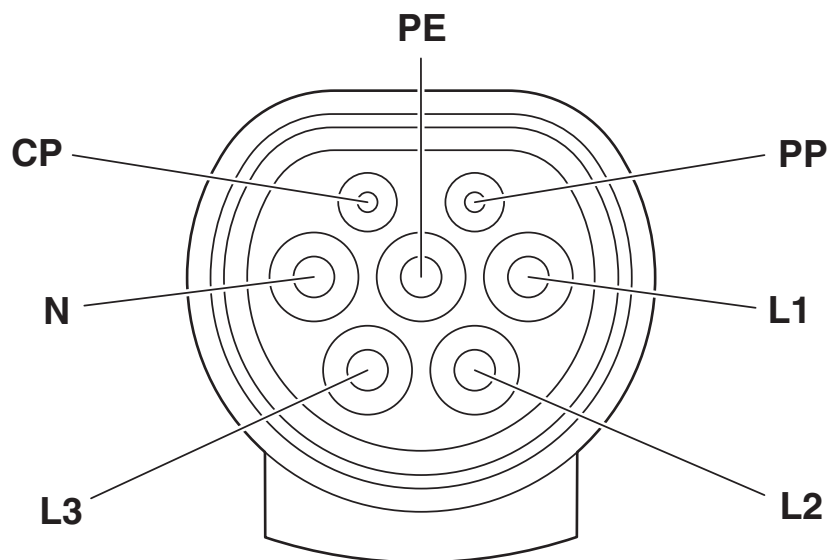

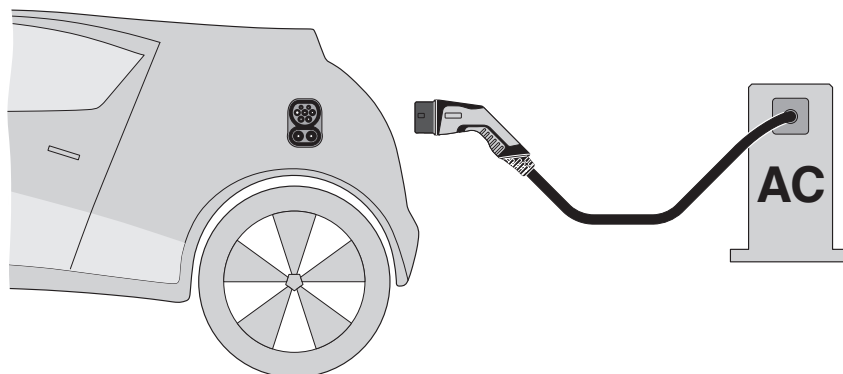
